**ANDREW NOTA TO BE APPOINTED EAST GREENWICH TOWN MANAGER
PUBLIC INTRODUCTION – 7:00 PM, TUESDAY, AUGUST 6 AT TOWN HALL**

EAST GREENWICH, RHODE ISLAND – The Town Council is pleased to announce that Andrew Nota will be appointed the new Town Manager of East Greenwich. The Town Council voted in Executive Session on July 8th to offer the position to Mr. Nota pending negotiation of a contract. The public disclosure of that vote and the ratification of the contract will take place at a special Town Council Meeting, Tuesday, August 6th, at 7:00 PM in Town Hall. The public will have an opportunity to meet Mr. Nota at a reception in Town Hall following that meeting.

Mr. Nota was unanimously selected by the Town Council for his abilities as a goal-oriented team leader with a demonstrated record of success in strategic planning and management of municipal operations and finance. His career experience and skills prepare him well to manage the challenges of local government and deliver outstanding community services to our residents.

Mr. Nota is currently the Town Administrator in Jamestown, Rhode Island, where he directs and supervises all Town departments, prepares and implements the annual operating and capital budgets, and negotiates the town's labor contracts. He has completed capital improvement projects in Jamestown involving the fire station, waterfront, roads, and recreational facilities.

Prior to his appointment to the Jamestown position Mr. Nota served as Director of Administrative Services in South Kingstown from 2009 through 2014. He has also served as Director of Parks and Recreation in Narragansett.

Mr. Nota has built a strong base of community and institutional knowledge that will add value to our Town, including his involvement in leadership positions at the Rhode Island League of Cities and Towns, the Rhode Island Chapter of the International Cities/County Management Association and the Rhode Island Interlocal Risk Management Trust. He has worked collaboratively with a wide array of state, local, business and educational agencies including the Greater Newport and East Bay Development Corporation, The Governor's Task Force of Rhode Island School Conditions Assessment, and the Southern Rhode Island Chamber of Commerce

Mr. Nota has successfully competed for grant awards from the Champlin Foundation, the Rhode Island Foundation, and the Rhode Island Department of Environmental Management.

His educational background includes a Bachelor of Science and Master of Business Administration earned at the University of Rhode Island, and a Juris Doctor from the New England School of Law in Boston.

We are excited to have Mr. Nota move his office across Narragansett Bay to East Greenwich, and look forward to his contributions to our Town government and community.
