The Statewide Grand Jury of the State of Rhode Island charges:

**COUNT 1**

That ARAMIS SEGURA, alias John Doe, of Washington County, on or about the 1<sup>st</sup> day of January, 2022, in the City of Warwick, in the County of Kent, did operate a vehicle in reckless disregard of the safety of others with the death of Olivia Passaretti ensuing as a proximate result of an injury received by such operation of the vehicle, in violation of §31-27-1 of the General Laws of Rhode Island, 1956, as amended (Reenactment of 2002).

**COUNT 2**

That ARAMIS SEGURA, alias John Doe, of Washington County, on or about the 1<sup>st</sup> day of January, 2022, in the City of Warwick, in the County of Kent, being the driver of a vehicle knowingly involved in an accident resulting in the death of Olivia Passaretti, did not immediately stop such vehicle at the scene of said accident and as close thereto as possible and did not forthwith return to and remain at the scene of said accident until he

fulfilled the requirements as set forth in §31-26-3, in violation of §31-26-1(d)(1) of the General Laws of Rhode Island, 1956, as amended (Reenactment of 2002).

### **COUNT 3**

That ALICIA PECKHAM, alias Jane Doe, of Washington County, on or about the 1<sup>st</sup> day of January, 2022, in the Town of East Greenwich, in the County of Kent, did aid or abet ARAMIS SEGURA in that ARAMIS SEGURA, being the driver of a vehicle knowingly involved in an accident resulting in death in the City of Warwick, did not immediately stop such vehicle at the scene of said accident and as close thereto as possible and did not forthwith return to and remain at the scene of said accident until he fulfilled the requirements as set forth in §31-26-3, in violation of §31-26-1(d)(1) and §31-27-9 of the General Laws of Rhode Island, 1956, as amended (Reenactment of 2002).

### **COUNT 4**


That ALICIA PECKHAM, alias Jane Doe, of Washington County, on or about the 1<sup>st</sup> day of January, 2022, in the Town of Charlestown, in the County of Washington, knowing that Aramis Segura committed the crime and offense of duty to stop in an accident, death resulting, and not standing in the relation of husband or wife, parent or grandparent, child or grandchild, or brother or sister, by consanguinity or affinity, did harbor or relieve Aramis Segura to avoid detection, arrest, trial, or punishment, in violation of §11-1-4 of the General Laws of Rhode Island, 1956, as amended (Reenactment of 2002).

**COUNT 5**

That ALICIA PECKHAM, alias Jane Doe, of Washington County, on or about the 1<sup>st</sup> day of January, 2022, in the Town of Charlestown, in the County of Washington, knowing that a crime had been committed and not actively assisting the offender or assenting thereto, did conceal or keep secret the commission of a felony, to wit, duty to stop in an accident, death resulting, intending to obstruct justice or hinder the due course of justice or to cause the felon to escape punishment, in violation of §11-1-1 of the General Laws of Rhode Island, 1956, as amended (Reenactment of 2002).

**COUNT 6**

That ALICIA PECKHAM, alias Jane Doe, of Washington County, on or about the 1<sup>st</sup> day of January, 2022, in the City of Warwick, in the County of Kent, did obstruct Rhode Island State Police Trooper Dean Marr, an officer of the Rhode Island State Police, while in the execution of his office or duty, in violation of §11-32-1 of the General Laws of Rhode Island, 1956, as amended (Reenactment of 2002).






